



# Privacy Policy

## Donors and Foundations Networks in Europe (DAFNE) & European Philanthropy Calendar

Brussels, 23 May 2018

As a membership organisation dedicated to serving institutional philanthropy, we understand the importance of maintaining your privacy, keeping your personal information secure and complying with data protection laws that applies to DAFNE members and also to non-members. We are responsible for complying with the General Data Protection Regulation. This privacy policy describes what personal information we may collect from you, why we use your personal information and more generally the practices we maintain and ways in which we use your personal information.

### 1. General

This is the privacy policy of the Donors and Foundations Networks in Europe (“DAFNE”), an international non-profit association in the process of constitution (situation in May 2018) based in Belgium at 1000 Brussels, Rue Royale 94. DAFNE acts as the controller of your personal data, which it can obtain (i) directly from you, or (ii) indirectly through third parties such as your organization.

This privacy has been developed in May 2018 but can be modified at any time (please do check the website for the latest version).

### 2. Legal framework – privacy legislation

This privacy policy is subject to privacy legislation such as:

- a) the Belgian Data Protection Act of 8th December 1992 on the protection of privacy in relation to the processing of personal data (as amended) (the “Privacy Act”); and
- b) Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (“GDPR”); and
- c) All other applicable legislation regarding the protection of privacy and the processing of personal data.

### 3. Purpose for collecting personal data and legal basis

We collect your data mainly to send our newsletter, improve our service and, more generally, to easily communicate with each other. DAFNE also can process other personal data in accordance with the Privacy Legislation and this privacy policy, in order to:

- a) achieve the purpose and exercise its activities; and/or
- b) provide direct marketing regarding its activities such as alerts on new documents and studies, updates, info brochures, emails, marketing materials, invitations to events such as conferences (a. o. the annual DAFNE conference), exhibitions, launches, seminars and workshops and other information that may be useful to you; and/ or
- c) execute contract(s); and/or
- d) better understand your needs and preferences in order to adjust its services hereto; and/or
- e) acquire statistical data; and/or
- f) it is legally obliged to process the data or if it is necessary in the public interest.

Finally, your data also allows us to improve and facilitate your navigation on our website. We collect your data – personal or otherwise – for various reasons which are defined above. It includes the following data:

- your identifying information (surname, first name, e-mail address, delivery address and country);
- the type of domain with which you connect to the Internet;
- the IP address assigned to you;
- the date and time of your access to our website;
- the pages you viewed on our website;
- the type of browser, platform and/or operating system you are using;
- the search engine and the keywords used to find the website;
- your browsing preferences.

Most of your data is communicated to us by your active intervention. Other data, such as the date and time of your access to our website, the pages you have viewed, or your location data, are collected automatically through servers consulted and “cookies” placed on our website. For more information on what a cookie is, how it is used and the exact data it collects, visit our page concerning our cookie policy.

We use Google Analytics to record site usage. We have no control over the data gathered by Google or installed plugins within your browser. If you are concerned with the use of this data, consider using a tracking protection plugin such as uBlock Origin or install Google Analytics Op-Out Plugin.



#### **4. Personal data**

The personal data DAFNE can process are, amongst others, but not limited to: first name, name, email address, phone number, photo, birth date, gender, function within your organization.

With agreeing to this privacy policy, you guarantee that the personal data you have provided, are complete and correct.

We take pride in respecting the privacy of our users. We maintain a strict privacy policy and take all appropriate measures to ensure that our servers prevent, to the extent possible, any unauthorized leak, destruction, loss, disclosure, use, access or modification of your data.

#### **5. Users 16 and under**

If you are aged 16 or under, please get your parent/guardian's permission beforehand whenever you provide personal information to this site. Users without this consent are not allowed to provide us with personal information.

#### **6. Storage period**

We keep your data for the time necessary to accomplish the Purpose pursued. Once this goal is achieved, we either delete or anonymize them.

#### **7. Transfer your personal data to third parties**

DAFNE guarantees it does not transfer your personal data to third parties, unless:

- a) there is a legal obligation to transfer the personal data;
- b) DAFNE has a legitimate interest to do so.

DAFNE will not sell personal data to third parties.

Third parties to whom DAFNE may, or is obliged to, transfer personal data on the basis of the above categories, can be located within or outside the European Union. DAFNE cannot be held responsible regarding the transfer of personal data and cannot be liable for the further processing of the personal data by third parties.

#### **8. Your rights**

You may, at any time, request to verify, access, rectify, delete, transfer and object to the use of your data, as well as request the limitation of such use of your data. We will then make every effort to take the necessary action as soon as possible.
